NOMINATION FORM THOMAS E. FREDERICK AWARD OF EXCELLENCE

The NIAAA established the Thomas E. Frederick Award of Excellence in 1988 on the recommendation of the Past President's in recognition of Tom Frederick's invaluable contributions to the NIAAA. Frederick passed away in 1990 and this award honors one individual annually whose loyalty to the NIAAA and contributions to the athletic administrators profession best represent excellence in achievement portrayed by Tom. As an associate director of the National Federation and coordinator of its program of services for athletic administrators, Frederick was primarily responsible for the organization, development and leadership of the NIAAA during its formative years from 1977 until his retirement in 1989.

Tom Frederick was the consummate professional. His loyalty and dedication to the profession of the high school athletic administrator was apparent. Tom demanded excellence not only from himself but others. He was a person of integrity as well as a person of vision. A product of his vision is the continued success of the NIAAA and its professional programs. He was a great friend, and a dedicated and tireless promoter of the NIAAA.

NOTE: Past Presidents, current board members, previous NIAAA Award of Merit recipients and Hall of Fame inductees are not eligible for this award.

Guidelines for Past Presidents: (It is suggested you consult the POP manual section 5.492 before submitting a nomination)

1. Only NIAAA regular and retired members who have served in the role as an athletic administrator for interscholastic athletic programs are eligible for the TEF Award.
2. All information and comments submitted must be restricted to this form. Please do not attach any addendums, resumes, or letters of support.
3. It is also recommended that you **not** inform the nominee they are being considered.
4. All nomination forms should be in the hands of the immediate Past President by October 15.
 - a. (An electronic copy of this form can be obtained from the NIAAA office or the immediate Past President.)
5. The Past Presidents shall have the opportunity to discuss the merits of each candidate at the December meeting prior to voting. Only those Past Presidents in attendance at the December meeting may cast a vote.
